#### **Trustee's Comments**

Trustee Presley requested that an executive session be added to the agenda for a contractual matter. He also requested that the resignation of a police officer be added as a new item 'J' to the agenda under New Business.

Trustee Shepard requested that an executive session be added to the agenda for a personnel matter.

Trustee Wilder had a comment and an appeal for the residents. He noted that there seems to be a lot of litter on the village streets. He has been taking a bag with him on his walks and he picks up quite a bit and he wanted to ask people who are littering to please consider NOT doing that! (Especially people who are fishing on the bridge and down on Marble Street!) Our village DPW is working hard to keep the village cleaned up and so do other residents who are out walking-so if people would pick up after themselves that would keep our village looking nice! He encouraged residents to ask people who are littering to pick up after themselves.

# Mayor's Comments

Mayor Clarke:

- Mentioned an informational meeting for the North West Fire district at the Lysander Fire Station 1, 664 Lamson Road at 7:00 p.m. on July 22, 2014. There will be information on the proposed expenditure of about \$700,000.00 for fire safety and other necessary equipment and about \$370,000.00 on a tanker truck. The vote is to be held August 5, 2014. Please attend the meeting so that you will understand the proposal and you will stay informed.
- Reminded residents of the Canton Woods Senior Center car show from 5:00 p.m. to 8:00 p.m. on August 4, 2014.
- Wanted to thank the members of the Lions Club for a very nice dinner meeting that he recently attended.

#### **Department Heads**

Gregg Humphrey reminded residents that the kayakers from the Onondaga Canoe and Kayak Club will be in Baldwinsville next week at about 7:00 p.m. on Thursday, July 24, 2014.

The Mayor asked Gregg to clarify the pool requirements if a resident wants to install an inflatable pool in their yard. Gregg stated that according to NYS residential code if the pool is capable of holding 24 "of water or more it requires a permit, an electrical inspection and a fence around it. Dave Jones mentioned that even though there may be certain neighborhood covenants that won't allow inflatable pools the village will not deny a permit based on a neighborhood's private agreement.

Anna Custer said that she'd handed out the June financials and encouraged department heads to look them over and let her know of any questions or possible mistakes.

Ruth Troy shared again that Canton Woods 5<sup>th</sup> Annual Car Show will be from 5:00 p.m. – 8:00 p.m. on Monday, August 4, 2014. There is a \$10.00 entry fee and the form is available online if a person would like to enter a car. Also, at the Thursday, July 24<sup>th</sup> car show at the B'ville Diner the senior center will be the recipient of the 50/50 raffle proceeds. She wanted to thank the DPW for all of their help and support during the recent carpet and painting project. The project is complete and was done with gifts, grants and no additional taxpayer dollars. The Mayor did say that it looks very nice and it is so good for the morale of the folks who visit at the center.

Mike Lefancheck wanted to let the board know that some of the officers have completed the training for the use of the medicine 'NARCAN' which is administered when someone is suffering a heroin overdose. The department hopes to soon have all officers trained to use it when necessary.

Steve Darcangelo reminded residents that work continues on Marble Street, Mildred Street and Grove Street with the sidewalk project. There is also roadwork in a few neighborhoods that starts on July 18, 2014. He asked for everyone's patience as the DPW works hard to get maintenance work completed.

The Mayor then relayed a compliment from an Edgewood Drive resident-the owner said he was impressed seeing our workers on the job-because they are always 'working and moving' and they aren't sitting around doing nothing.

#### **Pending Business**

• <u>Lock Street Projects-Tabled Resolution #59/2014, to award the Lock Street Roadway Modifications</u> project as opened on Wednesday, June 11, 2014 and tabled on June 19, 2014.

Steve spoke and explained the tabled motion from the June 19<sup>th</sup> board meeting. The main issue was that the low bid was very high-higher than the amount budgeted for the project. So Steve took a step back, looked around for added funding and also asked Clough Harbor to redesign the project where some of the details could be kept with the same good intent which was to divert the storm water from the river.

The new design will change from the idea of a center median and keep the existing footprint of the road. They will change the parking lane so that the drainage is underneath. It will be a Leitchfield which will filter the water back into the ground. Steve will be able to review the redesign the week of July 21<sup>st</sup>. If it is satisfactory, he plans to then advertise and bid out the project again with the hopes that it will be more in line with available funding.

Trustee Wilder noted how disappointed that he and everyone on the Planning Board is that this project is being pushed back. He said that they want to encourage the developer to keep moving forward.
