## **Citizen's Comments**

Jerry Elliott had many positive comments about living in our pedestrian friendly village and how the village's sidewalk program has only enhanced that aspect in the last 5 years, but in saying that he noted there are a few areas in the business district along East and West Genesee Street and Oswego Street where the roads are congested and it's difficult for pedestrians to cross. He hoped that by bringing this up that there could be a possibility of expanding crossing opportunities in those areas to keep our village safe for both local pedestrians and those just visiting. The Mayor explained that the State roads are very busy and that they prefer that crosswalks are located at the intersections but thanked him for the suggestions. He also has been very worried for a long time about the sidewalk and crosswalk up at Oswego Street and Brown Street where the school path exits the school grounds near the Grace Episcopal Church. Trustee Stebbins knows that area well and the village hopes to address the lack of sidewalk there as soon as they finish the repair/replacement phase of the current sidewalk project.

- Said that Marble Street looks great! If residents haven't yet been down there they should go see how the parking lot and guard rails turned out. Mark Zack from our DPW was a great help and really saved the village money.
