Mayor's Comments

Mayor Clarke

- Spoke about a letter he received from Joe Cellini. Last week on Edgewood Drive, the DPW fixed some land at the edge of his driveway. The DPW took great care and did a beautiful job. It was a job well done.
- Mayor Clarke informed the public that if they have any issues, please call the Village or DPW or Police, instead of airing the problems on Facebook. There are always ways to get a hold of someone in the village if you need assistance. Just give the village a chance to respond.
- He informed everyone that the Community Scholarship Golf tournament will be held on September 30, 2023. For more information contact golf@bvillescholars.org.
- The Mayor spoke about legislation that is on the Governor's desk for signature. The Proposal is to not have pilot money included in the tax cap. This would be positive news for the village if signed. The Governor has until the end of the year to sign it.
- Mayor Clarke also noted that he heard from Rentfun! and there have been a total of 36 kayak rentals in three weeks.
- Also, the mayor indicated that the Chamber of Commerce is looking for volunteers to help with the Taste of Bville event on September 16, 2023. Interested parties can call 315-638-0550 to sign up.

Village Clerk Jody DePaulis asked for an agenda item to be added to approve the ESI Employee Assistance Program. **Treasurer** Mark Baker asked for agenda item B to be tabled until the next meeting.

DPW Superintendent Chuck McAuliffe noted that the black top is completed and went very well. He also noted that the storm that came through on August 7th, took out the pump station on Ellsworth Rd. The DPW will be working with the Onondaga County water and stream dept to get the area cleanup up. Also, McAuliffe noted that the water department will be flushing hydrants this week. EPA and Homeland Security audits went well. It has been a busy couple of weeks for the DPW.

Senior Center Coordinator Ruth Troy informed the board of the success of the Canton Woods car show on Monday, August 14th. Also, the rotary hosted the annual Senior Citizen picnic. There were over 100 people for an enjoyable event. Also, the Walk for the Woods will be on Thursday, September 14, 2023, at 4:00 pm. Refreshments will be served. Police Chief Mike Lefancheck spoke about the incident that happened at the school on Monday, August 15, 2023. The Police Department is working with the school and Superintendent on the incident and has been working on the case all week. Everyone wants to ensure the safety of everyone at school and there is no danger to the community.
