Minutes of the Meeting of the Village Board of Trustees held at Village Hall at 7:30 p.m. September 07, 2023

The Pledge of Allegiance was recited.

Resolution #94/2023 Moved by Trustee Cico, second by Trustee Collins Resolved that the minutes from the Village Board meeting of August 17, 2023, be approved. Carried

Citizen's Comments-Michelle Werth, who owns Werth Wealth Planning wanted the board to be aware of an increasing problem with smoke shop that is next to her business. Customers entering the smoke shop have been becoming aggressive to her clients, they are entering her business and it is becoming unsafe. They see this problem daily and the owner of BG1, Carrie Laug, sees the problem on a nightly basis. She has a female bartender and is worried for her safety when she must leave to go to her car. Michelle loves the village and does not want to look for another space. She also indicated that there is constantly trash outside the office space, and it is just not a good environment anymore. She is asking for more police presence on foot patrol to see if it would get a little better. Police Chief Lefancheck noted that he is aware of the situation, and he will be contacting her in a few days to speak further. The Mayor voiced his concern and told Michelle that he doesn't want her to go through what she is going through. Trustee Reinagel asked if there is anything that could be done with zoning laws. Attorney Bob Baldwin was going to investigate code violations laws.

Trustee's Comments

Trustee Reinagel wanted to let everyone know that he attended Onondaga County Executive Ryan McMahon's information session at Canton Woods, regarding plans for the area. Trustee Reinagel wanted to thank him for his work in the Community.

Trustee Collins wanted to welcome the kids back to school.

Mayor's Comments

Mayor Clarke

- Wanted to wish Theresa Gross, who turned 90, a very happy birthday. Theresa was the former host of "Remembering Baldwinsville" and a few years back was "Women of the Year".
- Mayor Clarke noted that he finally got over to the Angry Smokehouse and had a very nice meal on the deck with some members of his graduating class.
- He informed the residents that the Chamber of Commerce has done a great job with the visitor's center, and it couldn't be done without the volunteers. Great volunteer spirit.
- The Mayor just reminded residents that school is now in session, so watch your speed, and be careful.
- Mayor Clarke also noted that on Saturday, September 16, 2023, the Taste of Baldwinsville will be on Paper Mill Island.
- The Mayor called for an Executive Session to discuss a personnel issue.

Department Heads

Attorney Bob Baldwin just mentioned he has not heard anything from the Angry Smokehouse on their boat situation for next year.

Treasurer Mark Baker noted that he has agenda items that can be discussed when they are up for motion, 7A) ARPA funds vs Highway repair money, 8B) Statutory Installment bond, is earlier than anticipated. Also, NY class deposit happened this week, now 1 million dollars has been deposited with them. Treasurer Baker also spoke about 4 funds, DPW Storage reserve is now earning interest with \$30,000 in fund. Water Storage Reserve, (new well source for water supply) has about \$20,000. Main Water Repair Reserve has about \$350,000 and Sewer Repair Reserve has about \$360,000 in accounts. Trustee Reinagel asked where the interest is accrued to, and Treasurer Baker stated it goes right back into the funds. Trustee Stebbins asked if more money is put into the accounts, does that money have to be put back in those accounts. The answer was yes, it does have to be paid back into those funds. A further discussion ensued regarding reserve funding.

Senior Center Coordinator Ruth Troy wanted to expand on what Trustee Reinagel stated about the visit from County Executive Ryan McMahon. He spoke about how Micron was coming to the community and took questions from the audience. He also spoke about the \$100,000 grant that Canton Woods received for a new roof. Ruth wanted to thank both Town Supervisors and Trustee Reinagel for coming out that day. Also, she wanted to remind everyone that Walk for the Woods will be on Thursday, September 14, 2023. Troy also wanted to inform the public of the fall prevention awareness classes at the senior center. It is a free program with great information.

Superintendent Chuck McAuliffe told the board that with the incoming stormy weather, the retention ponds are working. The water department is almost done with the hydrant flushing. Had a 2-day audit by the EPA, and that went well.

Police Chief Mike Lefancheck informed the group that NYS legislation passed the Professional Policy Act. This act stated that police departments in NYS had to be certified by the end of October 2023. Chief Lefancheck had to send in a lot of policies and procedures and examples of various department activities to become certified. He has heard back from the state, and the Baldwinsville Police Dept did pass the certification and they should be receiving that shortly. He also wanted to echo the comments that school has started. Please stop for school buses and plan for extra time on the roads.
